SMALL BUSINESS EMPHASIS

TRANSPORTING THE ESSENTIALS 80.3% of Indiana communities depend exclusively on trucks to move their goods.

COMPETITIVE WAGES

- Total trucking industry wages paid in Indiana in 2017 exceeded \$8.6 billion, with an average annual trucking industry salary of \$45,399.
- Heavy and tractor-trailer truck drivers held **51,830** jobs with an average annual salary of **\$46,270** (U.S. Bureau of Labor Statistics, May 2018).


SAFETY FIRST

COMMITMENT TO SAFE DRIVING

The IMTA promotes safe driving by offering a specialty license plate for four-wheel vehicles and motorcycles. The funds from this



plate support educational events for youth throughout the state of Indiana on the dangers of distracted driving and also how to share the road with trucks. The IMTA also partners with professional truck drivers through the Share the Road program.

THE INDUSTRY

\$1.2 billion

Amount the trucking industry in Indiana paid approximately in federal and state roadway taxes (2016). The industry paid **52%** of all taxes owed by Indiana motorists ...

... despite trucks representing only **11%** of vehicle miles traveled in the state.

INDIVIDUAL COMPANIES

OTRUCKS DELIVER A CLEANER TOMORROW

EMISSIONS

Through advancements in engine technology and fuel refinements:

- ✓ New diesel truck engines produce 98% fewer particulate matter (PM) and nitrogen oxides (NOx) emissions than a similar engine manufactured prior to 1990.
- Sulfur emissions from diesel engines have also been reduced by **97%** since 1999.

FUEL CONSUMPTION

The trucking industry continues to improve energy and environmental efficiency even while increasing the number of miles driven. In 2016:

- Trucks accounted for just **17%** of the total highway transportation fuel consumed.
- Trucks consumed 100 billion fewer gallons of fuel than passenger vehicles in the U.S.
